## 5. President's Report—Gretchen Douglas

Information Literacy Track at CIT - At the end of January I was part of the Abstracts and Program Committee for CIT. The committee spent two days reading and scheduling the abstracts for this year's conference. The response to the call for submissions in the information literacy track was phenomenal. The track was filled to overflowing with interesting papers and panel presentations. The veterans on the committee commented several times that the quality of this year's abstracts were the best they've seen. Some of the topics that will be presented are:

Successful collaboration with faculty
Searching the web
Information Literacy credit-bearing courses
Research oriented web pages in large lectures
Marketing information literacy to students
Using WebCT in information literacy instruction
ACRL standards

Cerise Oberman, a nationally recognized expert in information literacy and the recent recipient of the Distinguished Librarian Award will be honored by SUNYLA

at the CIT conference. She will be honored after lunch on Wednesday during a meeting gathering that the Chancellor will attend. I would like to make a motion that SUNYLA pick up the expense of her registration at the conference, as well as her lodging. The cost of registration is \$125.00. Dorm rooms, single occupancy, are \$35.00 a night.

Discussion ensued on this point. Mark Smith stated that we should pay for a hotel room for Ms. Oberman, rather than a dorm room. Hotel rooms are \$55.00/night.

Mark Smith moved to release \$250.00 for Cerise Oberman to attend CIT. Carol Ann Germain seconded. Approved by all present.

Aleph Users Group - A draft of the bylaws has been completed.

SUNY Council of Library Director's Meetings - SUNYLA representatives are part of a Library Statistics Team. The team has recommended that the SUNY statistics report coincide with the federal statistics report, which is done every 2 years. Currently SUNY statistics are collected every year. The committee also recommended taking ARL e-metrics standards to incorporate into SUNY statistics.

Another initiative discussed at the meeting is the New York State Higher Education Initiative (NYSHEI). Private and public schools would work together to purchase databases. Funding would be based on size of the school. Several large private universities such as Cornell and Syracuse University have already committed to the project.

Several SUNYLA members have e-mailed me expressing concern that they would like to attend both CIT and SUNYLA conferences this year, but feel they will have to make a choice between the two. I have asked library directors to make every effort to have librarians attend both conferences.

5.0 Committee Reports

### 5.1 Automation and Information Technology—Bill Drew

### Committee Charge:

"The Automation and Information Technology Committee shall serve as a focus for the exchange of information about automation and information technology; increase understanding of its impact upon library personnel and service to users; seek to increase the cooperation among SUNY libraries, computer centers, and other information-based units in the development/acquisition of university information systems; and establish liaison on automation and information technology with other SUNY professional organizations as appropriate."

The committee has been working on writing goals and objectives. Each member responded to a short survey of where the committee should go. Attached are the proposed goals and objectives currently under review by the committee. Final goals and objectives will be written in April. I regret that I am unable to attend the meeting on March 22, 2002. As chair of the committee, I am presenting the following two ideas for discussion and vote.

- 1. Move the SUNYLA council discussion group to the ITEC Lyris listserv in Buffalo. This will allow me to better manage the list. Currently I manage it entirely through e-mail. Moving the list to ITEC will allow me to manage it via the web. I would handle the entire transfer. I am presenting this as a formal motion as chair of the automation committee.—John Schumacher mentioned that Cary Hatch was interested in moving the list to the ITEC server, and that there were added features (such as archives) that would be of interest to us. Gretchen Douglas called for a vote. **Unanimously passed by all present.**
- 2. The committee is prepared to offer a new service via the ITEC listserv. We will set up a discussion group for any committee interested. All it would require from that committee is someone to be owner of the list. As chair of the automation committee I would be the list administrator and provide technical support. Anyone wanting to move a current list is also welcome to use this service. I am presenting this as a formal motion to get the blessing and support of the council.—There was no interest in persuing this at this time.

### 5.4 Professional Development—Carol Ann Germain

PD Grants Subcommittee - One grant has been awarded. Jennifer Quigley was awarded \$300. as partial tuition reimbursement for attending the Information Literacy's Immersion '02 program.

Sylvia Chu Scholarship Subcommittee- The deadline for the Sylvia Chu Scholarship was March 10th. We have received numerous applications that the subcommittee is currently reviewing. We did not receive as many applications as we have in the last few years. This could be because we changed the award structure. This changed from open reimbursemnet requests to conference registration, one continuing education program, and conference meals. The new structure will certainly limit confussion with what to award each recipient and treaser reimbursement headaches. My two cents: even though we did not receive as many requests, we still received a healthy amount and can consider the scholarship program a success.

Friend of SUNYLA Award Subcommittee- We received no nominations, even though it we did advertise. Personal solicitations to people have been made for nominations. Some suggestions but not official nominations: Chris Zagar of Useful Utilities, the guy behind the EZProxy software, was nominated last year and would one choice. FACT might be another excellent nomination. We'll need discussion here!

Carol Ann moved for FACT to receive the Friend of SUNYLA award this year. Mark Smith seconded. Unanimously approved by all present.

Continuing Education - CE cosponsored one regional program with Rochester Regional Council. This was a three hour session

on writing grants. There were twenty participants and yours truly presented (this was the same program as a 2000 Annual SUNYLA Conference CE). They were to co-sponsor a session on the tenure process but there was not enough interest in tha selection. At this year's annual conference we will be presenting The Dreaded Dossier: Making it Less Painful!

# 6.0 Liaison Reports 6.1 UUP & OLIS—John Schumacher

### SUNY Office of Library and Information Services

### SUNY Connect LMS

- Binghamton, Fredonia, Oswego, Tompkins Cortland are using the ALEPH500 software.
- Stony Brook is scheduled to "switch to production" March 28, 2002.
- Group2 campuses: Broome, Cayuga, Cortland, Herkimer, Morrisville, Onondaga, and Upstate Medical are scheduled to "STP" in May-June 2002.
  - Group3 (Canton, Delhi, Jefferson, Oneonta, Orange, Potsdam, Purchase, Rockland, Stony Brook HSC, Sullivan and Ulster) to begin implementation process in July 2002.
- · Binghamton, Fredonia and Oswego are receiving technical support from Ex Libris Customer Support (rather than from Implementation Services).
- · Serial publication patterns have been successfully loaded into a number of SUNY Connect LMS (ALEPH500) systems.
- SUNY versions of various ALEPH500 configuration files (for indexing, web opac, and other configuration tables) are in use. The number of these "template" files is expected to increase over time.
- An OLIS-designed and presented "Introduction to ALEPH" class will debut March 26, 2002.
- The OLIS has created a "SUNY ALEPH500 Portal" <a href="http://www.sunyconnect.suny.edu/aleph/">http://www.sunyconnect.suny.edu/aleph/</a>

A meeting was held in Syracuse with representatives from ITEC, OLIS and Oswego to discuss the multi-campus server environment and associated hardware and service support issues. ITEC has agreed to take on SUNY *Connect* LMS hosting responsibilities.

### SUNY Connect Databases

- The SUNY Connect Advisory Council has opted to not change the rate of increase for the campuses' annual Database Fee. This issue will be re-considered in August 2002
  - for possible implementation effective with FY 2003-2004..
- SLiCAT is in the process of a complete evaluation of the electronic resources offered through SUNY Connect.
- Database trial recently completed: full-text database of The Nation.

## SUNY Connect Document Delivery Service

Nylink is planning on sending out another RFP in this regard.

## SUNY Connect Shared Remote Storage

An initial study has been completed. Site visits to Binghamton, Oneonta, Cortland and Oswego have been scheduled.

## **SUNY OLIS**

Currently, there are no plans to replace Associate Provost Christine Haile. The Advanced Learning and Information Services' Assistant Provosts (including OLIS' Carey Hatch) are sharing portions of Ms. Haile's duties, and are reporting to Senior Associate Provost Richard Steiner. Likewise, plans to hire a Chief Information Officer for SUNY System Administration are on hold.

### **UUP Liaison Report**

- Proposed "flat" budget for SUNY is really a 5% cut (as a result of inflation and previously negotiated pay raises). UUP has received a verbal agreement from the governor and the chancellor of no layoffs and no tuition increase, but each campus would have to deal with this shortfall individually.
  - Lobbying efforts are underway to close the 5% gap mentioned above, provide funding for more full-time professors, and increase funding for Health Science Centers and the University Colleges of Technology.
  - Other legislative priorities include the areas of "pension equity" (for Optional Retirment Plan participants) and an Early Retirement Incentive that allows for retiring members' jobs to be re-filled.

- · UUP was successful at being included in the recently passed healthcare legislation. This resulted in an additional 90+ million dollars for the SUNY hospitals.

- The final round of salary increases (for the current contract) occurs this year. Members will be asked for input regarding the next round of contract negotiations

The COA (Computer Officer's Association) Executive Board meets monthly via conference call. Topics of concern this year include:

- SUNY Technology Conference. "New Solutions in Our Changing World", June 16-19, 2002, Hudson Valley Resort & Spa.
- Bylaws revision COA continues this project, begun last year, to bring the bylaws in-line with the current needs of the organization
- SUNY Council of CIO's This is a new organization, formed last year. This year they have formalized bylaws, elected officers, and created four standing committees: Network Initiatives, IT Personnel Issues, Software Contracts, and Technology Policies. Rich Reeder (Stony Brook) is chair; Justin Sipher (Potsdam) is vice-chair. (I view this organization as analogous to SCLD, with COA being analogous to SUNYLA.)
- Network Initiatives SUNY is working with AT&T using the current OGS contract to provide backbone services, both Internet and Quality of Service. They are currently in the testing stage.

I would like to take this opportunity to report on a related issue. SUNYConnect has purchased from AT&T a T-1 line to Oswego for the exclusive use of project. This line includes Quality of Service provided by AT&T and is \_outside\_ the Oswego campus network. This means that library traffic is separate from and not impacted by local campus traffic or outages. Already, this strategy has proven successful! Thanks go to OLIS, SUNYNet, and pilot computer center and network folks for this design.

A classroom without walls is not just students and instructors accessing computers at different locations; it should make available special experiences and resources that are beyond the reach of traditional education.

Software for the Disciplines: How are innovative software tools being used to enhance discipline-specific learning?

### 6.4 SAC—Laura Cohen

The SUNYConnect Advisory Council met on January 22 and March 5. Highlights:

- SAC approved a revised migration schedule. In this schedule, a few campuses have been moved to different time frames. Time frames have been adjusted to reflect the six month delay in project, and have been expanded from six to seven months to more accurately reflect migration schedules. Each migration time frame is also assigned a "group" number; i.e., sites currently implementing are "Group 2."
- SAC
   decided that the database fees will not be raised at the present beyond the increase already established in the current financial plan. A core database package will first be established

by SLiCAT, and any increases will then be set for the next fiscal year (2003-2004). According to the proposed time frame, implementation of the core database package will begin rolling out between July and December 2003. Current subscribed products, if discontinued, would then be phased out as their renewals come due.

- A representative from Ex Libris offered an SFX demonstration at the March 5 meeting. SAC has authorized the implementation of SFX at pilot campus sites. If the pilot goes well, SAC will consider purchasing a SUNY-wide license.
  - Nylink is still talking to vendors about a state-wide delivery service. Another RFP will be issued in the Spring

Discussions are being held between ITEC and OLIS to explore the possibility of using ITEC as an Aleph 500 multi-campus server site. ITEC may also serve as a single contact point for technical support of SUNYConnect hardware, operating system, Oracle and associated network connections.

An update on the initiative will be presented at Nylink's Annual Meeting [April 29-30].

### **OCLC News**

FirstSearch renewals for July 2002: OCLC is planning to implement annual price changes for the OCLC FirstSearch service on July 1, 2002. Nylink and OCLC are sharing this information earlier than in past years to give librarians more time to prepare for the upcoming changes and to take advantage of current per-search prices before July 1. On July 1, 2002, per-search searches will increase from \$.67 to \$.85 for OCLC members. The per-search price increase helps OCLC retain per-search access to the OCLC FirstSearch service.

The pricing increases for unlimited access based on annual subscriptions are maintained at an overall increase of 6-8% for all OCLC databases. For third party royalty databases, changes are made as their providers' royalty payment requirements change. We encourage Nylink members to purchase blocks of searches prior to July 1. ## 6.6 New York 3Rs Organization (NYTRO) Liaison Report—Jeannette Smithee

\* 3RsElectronic Resources Advisory Group Meeting: March 4, 2002

A group of 19 people, academic librarians from SUNY and private colleges and 3Rs staff met to discuss the guidelines for using CCDA grants for electronic resources and the possibilities of statewide purchase of databases for academic libraries. Marilyn Douglas, from the New York State Library, described the CCDA program. The group requested clarification about the program and

the guidelines.

- · The CCDA program focuses on resource sharing, traditionally ILL.
- The guidelines call for making e-resources available on-site to others in 3Rs region.
- $\cdot$  CCDA forms allow various ways that CCDA funded collection may be used.
- · On-site use is acceptable for print and e-materials resource sharing. There is no CCDA police!

Marilyn Douglas stated that the timing of the CCDA applications will be moved up to accommodate a decision-making timeline for requesting electronic resources. She hopes to have the applications ready this spring instead of in the fall.

John Stromquist talked to the group about the process of negotiating with vendors for statewide licenses.

John Shaloiko from the Southeastern 3Rs led a discussion on possible titles from a number of vendors / contractors for proposing as shared titles for academic purchase. Additional information will be sent from the 3Rs at the same time as the CCDA application materials are sent.

\* New York State Library Association Library Day in Albany, March 19, 2002

Librarians from all types of libraries met with legislators from their districts to advocate for increased funding for libraries. The legislators, at least from the Central New York region, acknowledged the importance of

increasing funding for libraries, but were pessimistic for the current cycle.

The 3Rs directors met with the legislative leadership and staff from the Governor's office to talk about the importance of academic and special libraries in the statewide library network.
