What Have We Done for "Us" Lately?

Here it is, my first official column as President of SUNYLA. Shall I pontificate on issues, innovations and trends in library and information service? Or, shall I comment on the work of state and national organizations that share our concerns and interests and comment on how we may help to implement their ideas in our rapidly changing service environments? I could also climb back up on my soapbox and continue to encourage the membership to help SUNYLA seek alliances and opportunities to work in partnerships with various SUNY and non-SUNY organizations that share issues of concern. But no, I am going to use this forum in this issue to illustrate several reasons why I feel fortunate to be a member of this organization.

On our campuses and throughout SUNY we are increasingly seen as the implementers, the change agents, and the essential service providers. We are the "doers." We are continually "doing" for patrons, "doing" for colleagues, and "doing" for administration. Perhaps it is time to take a minute, step back and ask ourselves an important question. What have we done for "us" lately? This is a question that we don't always think to ask, but whose answer makes me proud to contribute my efforts to our organization.

What *have* we done for us lately? For the answer, I refer to some items highlighted in the minutes of the past 3 council meetings (since March 1999). There are many examples to be found in these documents. Here are just a few of them:

Advocacy:

- We have established an advocacy committee to investigate and report to us on issues that need our support and comment.
- We have advocated directly to SUNY Board of Trustees and Regents Commission on Libraries regarding issues of critical importance to the membership.

Administrative:

- We have established a Web manager position that has clearly enhanced the visibility, organization and accessibility to our resources.

Professional Development:

- We have held another outstanding conference in which we had an opportunity to share and provide information on the widest range of issues and topics that effect our work.
- We have strengthened support to new members and provided additional scholarships and grants to encourage participation.
- We have awarded a professional development grant to study uses of Metadata. This grant also resulted in a presentation to membership at our annual conference.

Outreach and Collaboration:

- We have partnered with OLIS and ALIS by serving on several new committees and advisory panels in support of new SUNY initiatives in Library and Information technology.
- We have benefited by the efforts of several members who have made presentations and advocated on our behalf to our non-librarian faculty and technology colleagues on a variety of library-focused issues and initiatives.

Research:

- We have supported or conducted several surveys, including our biennial librarian salary survey, a survey of SUNY libraries and Distance Education, and a survey focusing on "Access to Materials in SUNY Libraries."
- We have enjoyed significant enhancements to the SUNYLA Library Instruction Website.

On Membership:

- We have increased membership to over 420 members.
- We have developed a new association brochure detailing the benefits of membership.
- We have begun recruiting members from library assistant ranks and are poised to actively recruit members from library schools.

These are just a sample of contributions made in the past few months. There are many others. These are simply a few illustrations of the types of things we "do" for us. Many individuals and subcommittees are directly responsible for these efforts. And, many individuals are supporting the association in other unsung ways, not the least of which include performing the numerous administrative duties required to support such a large and growing organization. We should all take pride in all these accomplishments. These are association supported activities.

In midst of all the rush and wild effort of "doing" for all of our various constituencies, let us remember that we belong to an organization that accomplishes much. Your membership is your opportunity to "do" for "us" and your contributions are appreciated by all. Please consider making your contribution to our continued success. It is your chance to do for "us." I look forward to serving and benefiting from all of our work over the coming year.

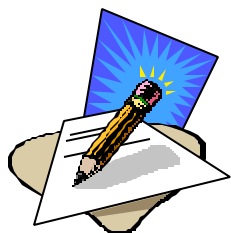

The Archive is a joint venture of the Geneva Library at Cornell's Agricultural Experiment Station, the Division of Rare and Manuscripts and the American Society of Ecology and Viticulture – Eastern Section, who kindly donated \$2500 to kick-start the project.

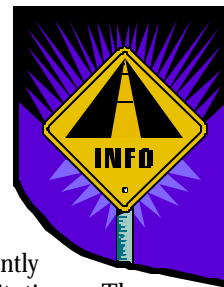

1999 Conference Report

Attendance:

Approximately 150 people attended the SUNYLA '99 conference, held June 16-18 at Adirondack Community College in Queensbury. The theme of the conference was "ACC 99: Advocacy, Coalitions and Cooperation."

The Friend of SUNYLA Award was presented to **Christine Haile**, Associate Provost of the Advanced Learning and Information Initiatives at SUNY System Administration. We hosted 30 speakers, including the pre-conference workshop presenters. Keynote speaker **Karen G. Schneider**, author of the "Internet Librarian" column in *American Libraries*, gave an entertaining presentation on filters and Web issues.

Roundtable discussions were held on four topics: libraries and academic computing centers, library management issues, technostress, and information literacy. Nine poster sessions were offered, on subjects ranging from a librarian exchange in China to managing a database management system for periodicals.

The conference offered three pre-conference workshops:

- Library Budgeting by **Katharine Winderlin** and **Barbara Nichols Randall**, on the components of a budget and how to organize a budget spreadsheet using Excel;
- Advocacy and SUNY Libraries: What Works, What Doesn't by **John Hammond** and **Kathleen Miller**, with practical, real-life advice on how to build and keep support for your library and its services;
- Building Coalitions with **Mary-Alice Lynch** and **Carey Hatch**, on the role of consortia, the organization of consortia in the New York State and SUNY library systems and the dilemmas and choices facing consortiums and the benefits they create for their members.

Cultural events include a tour of historical downtown Glens Falls, a visit to the Hyde Collection, a scenic dinner cruise on the Mohican on Lake George with dancing to the music of Doc Scanlon's Rhythm Boys, and a reception in the ACC Visual Arts Gallery, sponsored by Joy, McCoola and Zilch Architects and Planners, architects of ACC's new Scoville Learning Center building. Film clips portraying librarians and a film featuring librarians provided entertainment one evening.

Vendor and library services support was very strong this year. We received donations from Baker & Taylor, Blackwell Information Services, Blackwell North America, EBSCO Subscription Services, Fortres Grand Corp., Joy McCoola and Zilch, Nylink, SIRS Mandarin and Yankee Peddler. Vendors also donated additional items for the "goody bags".

Evaluation forms:

Fifty-two evaluation forms were received. Some highlights:

* Most people heard about the conference through the SUNYLA-L discussion list, their SUNYLA delegate or from the conference brochure or SUNYLA newsletter.

* Among the programs attendees rated as “excellent” were the keynote speaker, information literacy roundtable discussion and electronic reserves. Almost all other programs received ratings of “excellent” or “above average”. None received a rating of “poor”.

* Several commented that the roundtable discussions should be given additional time.

* Most rated the on-campus meals and refreshments as “Excellent” or “Above average”. The Thursday night band and boat ride (though not the food) also received rave reviews.

* The evaluations included an excellent array of program ideas for next year, as well as ten volunteers to help with next year’s conference.

SUNYLA’s new second vice-president, Debbie Emerson, has received a copy of the evaluation form results and list of volunteers to help plan SUNYLA 2000.

Conference Program Reports:

Below are accounts of several of the programs, written by conference committee members who served as moderators. In addition to those summarized below, other programs included:

- Digital Libraries: Virtual Realities by **Marsha Spiegelman**, on the opportunities and challenges offered by virtual libraries, such as the issues of access, instruction, quality, cost, staffing, support and collaboration.

- Bibliographic Access to Digital Resources: a Look at Metadata, by **Kate Majewski** and **Judith Hopkins**, on describing and providing access to digital collections and other electronic resources;

- Librarian as Partner in Campus Leadership by **Marilyn Rosenthal**, on the practical advice and experiences on creating a campus presence for the library and the role of librarians as library advocates and campus leaders.



Distance Learning: Making It Work

Special Note: Permissions of students enrolled in DL classes to feature their discussions on the web were obtained prior to showing the sites for the conference. Speakers featured distance learning web sites at University of Illinois LEEP Program and University at Buffalo School of Information & Library Studies where they are instructors.

Moody uses synchronous and asynchronous Internet technology, favoring the live sessions at U of I. She uses a 28.8 modem connection geared at low level technology with a separate phone line. Using a combination of general Web boards, chalk boards, text chat, and audio feed, she also makes provision for "private conferences." Students and instructors in LEEP are required to attend an intensive two week orientation to program on campus during the summer; and Moody attributes high degree of familiarity with students to this feature. Web boards are standardized throughout U of I programs.

Ellison, who teaches 5 classes via DL at SILS and one undergraduate course, has been using this method for more than 5 years. He uses web discussion boards to post class notes, query students and several techniques to engage students in discussion (i.e., Academic and Research Libraries is taught as a seminar; Intellectual Freedom is taught using the Socratic method; and Management is a high degree of interaction and project involvement. "Office hours" are maintained, and students are aware of this from

a syllabus posted each semester. Some classes have "optional classroom instruction." Both draw students from wide range of backgrounds, countries, and non-traditional student populations. Assignments are accomplished via web and traditional methods. Students learn of classes via print and electronic advertising, and word of mouth. The session spurred a high interest (pre-conference 37 registered) with lively discussion in the "how to" methods. Handouts listing Distance Learning URLs were provided.

SUNYLA Web Site Update - Deborah Bernard

This program consisted of live presentations of three SUNYLA Web Sites. **Laura Cohen**, Web Manager for SUNYLA, presented the main SUNYLA site and asked for suggestions for items to add. A lively discussion of what people would like to see on the site followed. Some of the ideas generated from this session have already appeared on the site. **Dan Kissane** unveiled the new Web page created by the Automation and Information Technology Committee. The site features lots of valuable information pulled together in one place. For some really useful tools, check out the System Support Tools and Web Site portion of the page.

Nancy Cannon, Bern Mulligan and **Janet Hogan** presented the Library Instruction Committee's Web site. Bern explained the overall structure of the site while Janet presented instruction pages created by several categories of SUNY institutions. There was a lot of feedback and discussion from the audience for all three sites.

Information Literacy Roundtable

Over 50 attendees filled Miller Auditorium for an active discussion moderated by **Tim Hamett**. Among the wide-ranging topics for this roundtable were:

1. Integrating information literacy into the college curriculum
2. SUNY Board of Trustees' recommendations on the core curriculum (i.e. information management).
3. Reaching out to part-time/adjunct faculty
4. Best practices/current initiatives
5. Tutorials on the Web and how best to use them in teaching
6. Getting faculty prepared and involved
7. Active learning and teaching
8. Computer literacy vs. info literacy

SUNYConnect/SLAM Update: David Moore

42 attended the session, presented by **Larry Randall**, SUNYConnect Project Coordinator and **Maureen Zajkowski**, SUNY Library Automation Migration (SLAM) Project Manager. Mr. Randall and Ms. Zajkowski's presentation covered the history of SUNY Library cooperative efforts, most notably the Library Automation Implementation Project (LAIP), which began in 1989 and is now serving 40 SUNY campuses as well as a model for SLAM. Joint database efforts date to 1995, when an ad hoc consortium of 32 SUNY libraries first subscribed to OCLC's FirstSearch. An up-to-the-minute report on the SLAM process was given by Ms. Zajkowski. A recommendation of a vendor should go to the SUNY Provost by July 1999 and the migration process beginning by the end of 1999. A brief question and answer session and discussion followed the presentation.

Electronic Reserves: Judith Adams-Volpe

A vendor package (E-Res from Docutek) and an in-house developed system were discussed by **Eileen O'Hara** from Brockport and **Karen Senglaup** from Buffalo. The two presenters discussed the systems themselves, student use, faculty reaction and satisfaction, staffing needs and workflow, costs

(including systems, staff, technical support, printing, and photocopying revenue lost due to no charging for printing at present), and finally copyright issues. The large audience was very engaged in the program and lively discussion focused largely on staffing requirements, the ease of use of the Docutek system, student use patterns, and especially the huge printing costs, the problems of initiating a pay system for printing (due to authentication needs) and the evolving status of copyright legislation/policy regarding digital reproduction of materials. The program provided precise information needed by campuses that are contemplating offering electronic reserve services.

Digitization Projects: Rudy Bruner and Love Canal at UB - **Kathleen DeLaney**

Presenters discussed history of a digitization project funded through a grant encompassing two dissimilar collections. The Rudy Bruner Award for Urban Excellence is a prestigious architectural award presented biennially with submissions archives at UB since 1987. The collection consists of b x w microfilmed entries of colored submissions presented in three-ring binders, including architectural drawings, schematics, landscape and interior plans. Viewed as a unique educational tool, two UB libraries receive frequent requests to ILL the films, with the chief complaint being that they are "difficult to impossible to read."

The Love Canal, the world's first manmade federal disaster, may not have been the biggest or largest toxic waste dump, but it has the distinction of being the first around which grass roots movements developed and is the benchmark by which all other crises after it has been measured. UB holds the records of the Ecumenical Task Force known as the Love Canal Archives -- more than 198 linear feet (more than 300,000 records). This collection is unique because it was assembled at the height of the crisis, and continued for 19 years thereafter. A major portion of the collection is newspaper clippings, with court and medical records, unique private/confidential memos, and other assorted business-type materials. Differences in the approach to digitizing a colorful, graphically rich collection (Bruner) as compared to a text rich collection (Love Canal). Examples of archival records were shown to compare them to digitized version. A labor intense project, part of the grant focused on experimentation with different image formats and the results of the web design. Conclusions included advice not to digitize unprocessed collections, and to retain an archival copy of any digital work in the most simple and flexible format based on changing technology, and to determine what it is you need and want to showcase on the web prior to digitizing.

SUNY Student Resource Center - Moderator: **Joyce Miller**

Peter Genovese, Director of Libraries at Monroe Community College and **Pamela O'Sullivan**, Manager of the SUNY Student Resource Center, presented a session to 15 people on the innovative SUNY Student Resource Center. The Center, based at the Rochester Public Library, is a cooperative effort between the Rochester Public Library, Monroe Community College, SUNY Brockport and Empire State College. The Center's purpose is to provide library and computer services to students attending those colleges' downtown campuses. The Center also provides reserve material for those campuses, training on Web use and word processing, numerous resource guides and pathfinders, group study rooms, and a reading garden. Telecourses may also be viewed at the Center. Students must have a valid ID card from one of the three affiliated colleges to use the Center. The Web computers have links to the campuses' web sites. The public may use the computers for limited times, but student have priority. To ensure the success of the Center, Peter and Pamela find that ongoing advocacy is required, promoting the Center's services by visiting classes and distributing handouts.

The Advocacy Committee

Purpose of Ad Hoc Advocacy Committee

When I started to write this article, I thought that looking at a definition of advocacy would be beneficial. According to Merriam-Webster Online, an advocate is “1: one that pleads the cause of another; *specifically*: one that pleads the cause of another before a tribunal or judicial court. 2: one that defends or maintains a cause or proposal.” “. The etymology of the word is even more interesting. One of the roots of the word is *voc* or *vox*, which is Latin for voice. Advocacy is defined as “the act or process of advocating or supporting a cause or proposal”. Going from this, I believe the major mission of the Ad Hoc Advocacy Committee is to provide a voice for causes and proposals supported by and beneficial to SUNYLA members.

How did this committee come about?

Mark Smith and I started having conversations just after Mark took on the duties of First Vice President/President-Elect. Various things happening within SUNY and in the library community required a response from our organization. No real mechanism existed to provide a fast turn around on such responses. As a result of our discussions, Mark suggested the formation of an Ad Hoc committee. He presented his proposal at the board meeting in August at Brockport. He asked me to chair the committee. That brings us to the present.

Charges to the Committee

Proposed charges to the committee are:

- Identify advocacy issues and potential actions that further the goals of the organization and are of direct benefit to the membership.
- Develop and recommend to the Executive Board a mechanism for sanctioned approval of "official position" communications by SUNYLA to all appropriate external organizations and persons.
- Compose statements, letters, press releases or position papers on advocacy issues to be presented to the executive board and council for discussion, approval and dissemination to appropriate and approved sources.
- Develop mass mailing communication "templates" (IE. letters to politicians) for use by the SUNYLA membership detailing advocacy positions to elected officials or government offices.
- Provide official sanctioned SUNYLA representation and voice at appropriate external meetings and forums where there exists an opportunity to advocate for the specific interests of the organization and/or stated objectives as outlined in Article II of the SUNYLA constitution.

What Now?

Please contact me if you are interested in this challenging and important effort. I see no need initially to meet face to face. Most of the work will be done via e-mail and telephone calls.
